Mr. Arroyo,

Per your request, I am writing to confirm the advice that I provided you over the phone regarding the conflict of interest law, G.L. c. 268A.

You are a Boston City Councilor. You advised that you introduced a home rule petition that seeks to eliminate the 2021 special election for Mayor. You inquired as to whether the conflict of interest law would restrict your participation in the discussion or vote on the home rule petition if there is a possibility that you may run in an upcoming election.

As we discussed, while Section 19 of the conflict of interest law prohibits municipal employees from participating in any particular matter in which they have a financial interest, the definition of "particular matter" specifically excludes home rule petitions:

*"Particular matter", any judicial or other proceeding, application, submission, request for a ruling or other determination, contract, claim, controversy, charge, accusation, arrest, decision, determination, finding, but excluding enactment of general legislation by the general court and **petitions of cities, towns, counties and districts for special laws related to their governmental organizations, powers, duties, finances and property.*** G.L. c. 268A, sec. 1(k).

Therefore, you may participate in the discussion and vote on the home rule petition regardless of whether you have an interest in running in any of the upcoming elections.
