Dear Acting Mayor Janey:

As you know, Sybil Mason made public allegations yesterday about Commissioner White. The allegations are false, contradicted by her own recorded statement to the police and the court in 1999 that there was “no physical abuse” in Dennis White’s relationship with her. *See* police report dated May 4, 1999, which is attached to Affidavit of Mary-Ann Riva. As a police officer, she was duty bound to tell the truth.

Her unsworn statements to the press today are also contradicted by the sworn statements of her daughter, her sister and Dennis White. The sworn testimony reflects that Sybil Mason has a pattern of abusing family that began as a teenager when she stabbed her brother in the upper thigh with a knife. According to the sworn testimony, she abused her daughter and also beat up multiple girlfriends and boyfriends through her adult years, including during her marriage with Dennis White when they were estranged. According to sworn testimony, there is a documented complaint against her for having assaulted a disabled female guest at her home, and she had her gun taken away by the Boston Police Department. According to Tiffany White, Sybil has disclosed that she has been under investigation more recently in connection with her police work. This possibly concerns overtime fraud, but I do not know.

Sybil Mason is not a credible witness and evidence of fraud and violent, assaultive behavior would tend to confirm what Commissioner White, Tiffany White and Connie Owens (Sybil’s sister) have said under oath about Sybil being the one who abused Dennis White (and many others), not the other way around. Therefore, I will be sending today a document request to the City in connection with the pending lawsuit for Sybil Mason’s files, including her Internal Affairs files, personnel files and any other records the City has concerning any actual or potential misconduct by Sybil Mason, including without limitation potential fraud as a police officer. Dennis White’s IA files and other personnel information have been reviewed and scrutinized publicly in this matter; Sybil Mason’s IA files and personnel information should also be disclosed especially because her allegations are central to the matter pending before you: whether to remove Commissioner White.



In the last day or so, Brittany White also made false unsworn allegations in response to the sworn video testimony of Tiffany White, Connie Owens and Commissioner White. Brittany White's statements are both highly improper and not credible. First, she has now made repeated threats to violently assault her sister, Tiffany White, and her aunt, Connie Owens, and has confirmed that she previously assaulted Tiffany. She has threatened this violence both in retaliation for their past statements and to curtail them from making any further statements in the pending legal matter. That is unlawful witness intimidation and reflects a desire to conceal the truth. Commissioner White, on the other hand, wants the truth to be told because it supports his position.

Second, Brittany White's statement are false and not credible. She made her statement over 70 minutes on Facebook Live during which she "smoked a blunt" and stated "F*** I'm high." Her statement is a rambling emotional rant, unsworn of course, that should not be given credence. To leave no doubt about its falsity, Commissioner White has prepared the attached affidavit so that you may know the truth regarding these allegations.
