NARRATIVE

On June 14, 2023 at approximately 12:02pm, PO received a phone call from [REDACTED] (144 McBride St) for an investigate child.

Upon arrival PO Marrero was met by [REDACTED] and other school administrators. They were concerned about a student [REDACTED]. They became concerned when [REDACTED] came to the school to take [REDACTED] home and made a statement that they will be withdrawing and enrolling her into St Columbkille in Brighthon because of the bullying that his "daughter" was receiving in school. The school found it odd because [REDACTED] was just enrolled on Thursday June 8th, and just earlier in the morning they had begun to address the bullying with [REDACTED] and [REDACTED]. Concerned that there may be some sort of custodial issue with the parents, the school began to ask from the district all of the enrollment paperwork. It was when looking through the paperwork that a school administrator had noticed that one of the forms submitted for enrollment was not right. A paper with

Comm of Mass heading that underneath it said "Department of Children and Families" Seeing this prompted them to investigate further. Admins contacted DCF to inquire if the social worker listed [REDACTED] was in the office. The phone number on the letterhead was incorrect, and the cell phone listed went to voicemail. A call to the DCF office in Lowell (as that is the office that the letter came from) and was informed that no [REDACTED] worked at that office. The person on the other end checked to see which office she may be out of, and no [REDACTED] was listed as a DCF employee. This prompted [REDACTED] to contact 911 and the TS03.

Also responding was the TS04 (Reyes).

This is what started the series of events into this investigation. Additional and more detailed information will be documented on internal administrative report Form 26.

Sgt. Det. Marc Sullivan of HTU was notified of this.
