NERRATIVE

At approximately, 09:50 am on Tuesday, 06/06/23, Officer Smith (YD21) was involved in a Motor Vehicle Accident at the intersection of Blakemore Street and Hyde Park Avenue in Hyde Park.

Officer Smith operating department vehicle # 2558, an unmarked Ford Mach E with MA REGISTIAN was headed down Blakemore Street approaching Hyde Park Avenue with lights and sirens activated. The traffic light at Blakemore Street was red. Officer Smith was stopped at the red light, then slowly approached the intersection to ensure that the oncoming traffic travelling outbound on Hyde Park Avenue were able to see and hear the cruiser entering the intersection. Let it be known that Hyde Park Avenue has two lanes of traffic travelling both inbound and outbound. The first lane of traffic travelling outbound on Hyde Park Avenue, observed the cruiser's lights and sirens and came to a complete stop. Officer Smith then proceeded to cross the second lane of traffic. Officer Smith was in the second lane of traffic when vehicle #1, black 2019 Honda CR-V with MA Reg approached and collided into the driver's side of the cruiser. Officer Smith was unable to avoid the collision due to vehicle #1's fast approach and did not stop or slow down for the cruiser's lights and siren.

Officer Barton who was performing a paid detail nearby and he notified Operations regarding the accident. Officer Smith's passenger who is known to the Commonwealth stated she felt a minor pain to her right side of her body but declined medical attention at the scene. She will seek medical attention at a later time, if necessary. Officer Smith exited the vehicle from the rear door and approached vehicle #1. The second who was identified as the driver of vehicle #1, was standing outside of the vehicle speaking with Officer Barton. The had a young child in her arms, and he was in back seat when the accident occurred. Officers Smith and Barton asked the second at if she and the child are alright and if they needed medical attention, but she declined for both of them. Boston EMS was still notified to respond to the scene to have both parties evaluated. Boston EMS A-17 arrived and transported and the child to the for further evaluations.

The V988 (Sgt Det Chin), Y982 (Sgt Det Canuto) and L911 (Sgt McCarthy) were also on scene. Who was standing across the street, in front of the Boston Police Detective Benevolent Society located at 434 Hyde Park Avenue reported that he witnessed the accident.

Officer Smith felt pains to the left side of the body and was transported by Boston EMS A-18 to for further evaluation. Officer Smith was seen by Dr. Gottshall and was discharged the same day.

Sgt McCarthy took photographs of both motor vehicles and the damages. Vehicle #1 has visible damage to the front end. Officer's cruiser has damage to the driver side including the front wheel.

Vehicle #1 was towed by Parkway Towing, tow slip number, 20292. Department vehicle towed by Always Towing. Boston Police Report of Department Vehicle Crash form and CRA-65 will be completed.
