Re: Support for Stay of Removal Application for A#

Dear Boston Field Office Director:

As members of the Vermont state legislature, we are writing in support of an Application for Stay of Removal submitted by Wuendy Bernardo Agustin (A# on November 10th, 2022. Ms. Bernardo Agustin and her family would suffer extreme hardship if removed from the United States; therefore, on humanitarian grounds, we strongly urge ICE to exercise its discretion and stay her removal.

Ms. Bernardo Agustin is a valued member of our community here in Vermont. She is the primary caregiver to her five children and her two orphaned younger sisters. Her large family relies on her and would be irreversibly harmed by her deportation. Wuendy is also a leader in the Vermont-based community organization Migrant Justice, advocating for workplace and tenant rights, improving working and living conditions on farms across Vermont and New York, and helping to make our state more just for all.

In the last legislative biennium, Ms. Bernardo Agustin played an active role in our community and our democracy, testifying to the Vermont legislature about barriers in access to healthcare as an immigrant mother. Her work resulted in landmark legislation creating the Immigrant Health Insurance Program, which covers medical costs for pregnant people and children regardless of immigration status. As a citizen legislature, we rely on the brave testimony of people like Wuendy to help us craft the best policy. She has more than demonstrated her dedication to our state, her commitment to civic engagement, and her respect for our democratic institutions.

As state elected officials, we join with others in respectfully requesting a Stay of Removal for Ms. Bernardo Agustin so that she may remain with her community in Vermont.
