NARRATIVE

At about 2:13pm on Saturday, May 16, 2020, Officers [REDACTED] assigned to the D107D unit responded to a radio call for a person with a gun at 134 Northampton St, Roxbury.

Assisting on the radio call was the D101D ([REDACTED]), D411D ([REDACTED]), D421D ([REDACTED]), D203D ([REDACTED]), D105D ([REDACTED]), D441D ([REDACTED]), D431D ([REDACTED]), D425D ([REDACTED]), D103D ([REDACTED]), D435D ([REDACTED]), D906 ([REDACTED]), D908 ([REDACTED]).

The 911 caller/victim (Known to the Commonwealth), stated that a Hispanic male in his 30's wearing a white t-shirt was threatening the caller with a gun in a bag. Officer [REDACTED] was first able to locate the 911 callers/victims (Known to the Commonwealth) and gain a further description and a direction of flight from the victim. Officer [REDACTED] was broadcasting that information over Boston Police Channel 5, when officers on Massachusetts Ave located a person matching the description of the suspect being broadcasted. Officers attempted to stop that individual to speak with him about the incident but the individual then ran from the officers. The individual, later identified as Tyler Brown (DOB 7/8/79), ran to the corner of Massachusetts Ave and Chester Park, where an exchange of gun fire took place between officers and Brown. Immediately after the exchange of gun fire, Tyler Brown was then placed under arrest by officers in front of 558 Massachusetts Ave. One of the responding officers stated to [REDACTED], "he was shooting at me", immediately after Brown was placed in custody. A witness to the incident that is known to the Commonwealth and was interviewed at Boston Police Headquarters gave an account of the incident. The following is not a verbatim account. The witness stated that he was inside his apartment on Massachusetts Ave when he heard the sound of gun fire. The witness looked outside his window and observed a male, heavyset, possibly 5'10", possible Latino or black wearing a white t-shirt or tank top and possibly gym shorts firing a gun, he then dropped the gun and raised his arms up.

All responding officers then aided in setting of a crime scene on the area of 558 Massachusetts Ave.

Officer [REDACTED] proceeded to 134 Northampton St to speak with the 911 caller/victims of the original incident. Officer [REDACTED] spoke with four separate victims, who are known to the Commonwealth. The victims stated that they were moving into an apartment at 134 Northampton St when they were approached by an unknown male who became confrontational with them. The unknown male asked the victims, "where are you from?" to which the victims stated that they were only just moving in. The unknown male then walked out of the outdoor hallway area and then returned, asking "where are you from?" again. The unknown male then stated to the victims "call your boys" and then reached into a green bag that the male was carrying. One of the victims was close enough to see in the bag and saw the unknown male grab a firearm from the bag. The victims then called 911 and stated to the unknown male that they

were calling the police. The unknown male then left the area by Washington St in the direction of Massachusetts Ave. One of the victims was able to provide Officer [REDACTED] with a picture of the unknown male in front of 134 Northampton St. The picture provided to Officer [REDACTED] showed a darker skin male wearing a white t-shirt, blue jeans and black /orange sneakers, carrying a green bag and a black bag. Officer [REDACTED] asked the victim if he could describe the firearm, to which the victim stated it was black and looked much like the officer's firearm. The four victims were transported to Boston Police Headquarters to be interviewed further.

A query of Tyler Brown's Board of Probation record showed that he was found guilty of Unlawfully Possessing a Firearm without a License out of Brockton District Court on 1/9/09 (Docket #0815CR006461) which would make Mr. Brown ineligible to possess a license to carry a firearm now. Tyler Brown was placed under arrest and charged with Assault to Murder (Ch. 265:15), Unlawful Possession of a Firearm (Ch.269:10a), Unlawful Possession of Ammunition (Ch. 269:10h), Large Capacity Feeding Device (Ch.269:10m) and Discharging a Firearm within 500 feet of a Dwelling (Ch. 269:12E). Brown was transported to District D-4 and booked in the usual manner.
