On January 28, 2025, KUTZKO, JOSEPH P DOB: 10/31/1956 of [REDACTED] SOUTHBOROUGH MA 01772-1214 allegedly committed Assault, Assault and Battery and Threats to Commit a crime. - The incident took place at [REDACTED] in the Town of Southborough. - I was contacted by Lieutenant Whelan and requested to respond to Algonquin High School to further investigate. - Joseph punched the victim with a closed fist in shoulder area. Joseph also grabbed the victim by her hair numerous times and tugged her towards him. - The victim didn't consent to the touching and was in fear. - Joseph pulling the victim by the hair and causing her to stumble was likely to cause bodily harm. - Joseph threatened battery by being less than an arm's length away from the victim when in her bedroom later that night. - Joseph raised his balled fist and stated that he wanted to punch the victim. - The victim was in fear that Joseph was going to hit her. - Joseph communicated to the victim that he would kill her for not singing in tune during a birthday celebration. - Joseph threatened the injury that if carried out would constitute a crime. - The victim was in fear of Joseph and believed that he had the intentions to do it. Joseph lived in the same house with the victim. - Joseph was held without bail and will be brought to the Westborough District Court in the morning. - This case is still under investigation and additional charges may be brought forward at a later date once this investigation is concluded.
